

CRIME WATCH VOLUNTEERS NEEDED

The Richland Park/Oaks Crime Watch needs more volunteers to help patrol our neighborhood. We have fairly good coverage during the daytime, but are in need of help for nighttime. Unfortunately, late night is when we experience most of our problems. Therefore, we need more volunteers at night, every day of the week. This is a great way to get out, meet new people, learn new things and experience something different in life.

In order to join the Crime Watch Patrol, you will need to fill out an application form which we submit to the Richardson Police Department. The police will run a criminal background check on each applicant. Once all the paperwork has been cleared, the applicant will receive about six hours of training. All new applicants will also be assigned a patrol partner.

Crime Watch Patrols are extremely effective because criminals do not want to get caught by anyone, police or otherwise. So when you put those reflective signs on your cars and patrol the neighborhood, the bad guys tend to go some place else. The problem is we need to maintain these patrols at all hours in order to keep crime away.

Each shift usually consists of one and half hours of patrol time every other week (total of 3 hours per month.) The two shifts where we need the most help are evenings (7 p.m. to midnight) and deep nights (midnight to 6:00 a.m.).



TRASH BASH APRIL 6th

Trash Bash 2013 will be held Saturday, April 6 from 9 a.m. until 1 p.m. Come and join in the biggest Trash Bash ever!

The clean-up celebration will begin around 11 a.m. at the Richardson Civic Center. Along with the clean-up event we will once again offer document shredding and electronics recycling sponsored by CPAAA, plastic bag recycling sponsored by Wal-Mart, educational booths, pizza and door prizes. The document shredding, electronics recycling and plastic bag recycling will be from 9 a.m. to 1 p.m.

New for this year, the Richardson Environmental Action League (REAL) will provide one free roll of 26 recycling bags for each Richardson residence to encourage more people to recycle. In light of this grand occasion, the City will provide up to 2.5 cubic feet (cf) of Texas Pure Compost, which is made from Richardsongrown tree trimmings, all collected through the highly regarded BABIC program. Please bring your own containers to take your compost home (four, 5-gallon size painter's buckets equal 2.5 cf, approximately). We will also collect clothing for NETWORK of Community Ministries. Items needed are clothing and coats for men, women and children. No undergarments please. Accessories such as shoes, ties and belts will be also accepted. Clothing should be gently used and washed. Place items in grocery sacks, paper bags or boxes. Please do not put items in trash bags.



West Nile Virus: A Neighbor's Story

August 2012, from a mosquito bite I believe I experienced while out in my yard. I was patient number 14 in Richardson, Texas, for 2012. The diagnosis was not confirmed until I made an emergency trip to the hospital on September 11th. In addition to three days in the hospital, it took 130 days for me to recover physically, which just occurred on January 1, 2013. Mental recovery from West Nile takes longer, averaging between 200 and 500 days. However, I am seeing improvement with that every day now. One's short term memory and mental focus are the

most affected. For example, you might not remember details of something that occurred as little as four hours ago.

I discovered during my five month experience, that there are a lot of unanswered questions about this virus. For that reason I decided to write this article, to share with you, my neighbors, important information to help you deal with this threat. I am not a physician, so the information I provide you is from personal experience, my research, and the research of those cited in the Resources section that follows.

Q & A

How did West Nile virus get here?

West Nile is primarily carried by the bird population as they migrate throughout the world. Mosquitoes feed on the birds, and then they transmit the virus to humans. It was first (continued on page 7)

seen in the U.S. in 1999 in New York City, but has since spread across the continental U.S.. The Dallas area had no cases in 2010, but then had a large scale outbreak in 2012. It is estimated from blood donor statistics, that as many as 25,000 individuals were infected in the DFW area last year. This virus can only be transmitted by humans via blood transfusions or organ transplants while the virus is active. Consequential blood contact (e.g...during dental work, or from a cut) does not transmit the disease.

What happens when a person is **infected?** It takes about five days after infection for symptoms to manifest. This virus attacks the brain, so while primary symptoms center on that, other symptoms can vary greatly. 80% of the population will not experience any symptoms or have mild cold/flu like symptoms for a few days. 19.9% of the population will have "intermediate symptoms" that will take from 90 to 120 days to recover from. These are debilitating symptoms that include extreme fatigue (sleeping 20-22 hours a day), very low stamina, headaches that won't go away, general neuralgia, and fever episodes 4-5 times a day (30 minutes to 2 hours each). For me these fever episodes were like a hot flash, where from the neck up I would feel very hot and would flush red over my entire neck, and face areas. That's how those around me knew something bad was happening. To be comfortable at all, I had to keep a fan blowing on me the full time I experienced this, and I would also place a wet wash cloth over my face. This "intermediate" experience is labeled by professionals as West Nile Fever (WNF). 1 in 150 cases (approx. 2/3 of 1%) will have severe, protracted, and potentially life threatening experience. This is referred by professionals as West Nile Neurological Disease (WNND). Symptoms progress rapidly from intermediate to severe typically in the first week after symptoms appear. Many patients end up in a coma for one to three weeks. The worst cases are West

or West Nile meningitis, (inflammation of the lining of the brain), or West Nile poliomyelitis which is a spinal cord inflammation that results in a syndrome similar to polio. Often a patient will have paralysis from the waist down that may last several weeks to several months. The patient then has to relearn how to walk, starting out in a wheel chair for a few months, moving to a walker for a few months and then finally using leg braces and a cane. Some individuals may never be able to get out of their leg braces. Underlying Conditions: You will often see it stated in news reports when someone has died of West Nile that

the deceased had an "underlying" medical condition that contributed to their death.

One of these conditions is if a person contracts the disease and they have previously had a transplant. One statistic I saw was that the survival rate for these individuals was only 1 in 7. Many seniors also have underlying conditions that may worsen when they contract this. During my recovery, I had four weeks of severe health issues, where West Nile was complicated by inner ear inflammation in one case, and in another, two different hormone levels were extremely low. In both cases, I was ill enough that I thought there was a chance I might die.

What Treatment Options Exist for this?

For West Nile Fever (WNF), there is only symptomatic relief where you take normal pain relievers and rest. A recent offering in Richardson is an Oxygen chamber that has helped some. For the more serious Neurological diseases, one typically has to be hospitalized for an extended period of time during the first three to four months to deal with the coma, paralysis, brain swelling, and physical therapy.

Is there a vaccine for West Nile? There is one for horses, but not humans. The incidence rate for serious symptoms is not great enough to motivate pharmaceutical companies to make the investment. It could take 10-15 years to do all the testing and get the approvals needed.

State of the City Address Updates Community on Accomplishments

n Wednesday, January 30th, Mayor Bob Townsend addressed members of the public, business leaders and civic leaders at the annual *State of the City Address* at the Eisemann Center. The event was free and open to the public was broadcast live on CITV and the internet. Replays will be televised and available on-demand on the City's website: www.cor.net.

Highlights from the address included the announcement of a \$1.6 billion, mixed-use, transit oriented developement adjacent to the DART Bush Turnpike Station. State Farm Insurance confirmed the signing of a 1.5 million-square foot office leasing space (the largest office lease in the Dallas area's history). Methodist Richardson Medical Center broke ground on a new, \$120 million regional hospital at Renner road near the President George Bush Turnpike. The existing Medical Center on Campbell Road will be renovated to maintain emergency/urgent care, primary care, and diagnostic and outpatient services, as well as to expand its post-acute services (rehabilitation and long-term care), and to add geriatric behavioral health services.

Mayor Bob Townsend discussed the 12 City Council initiatives in the 2011-2013 statement of Goals. Each one is highlighted and can be viewed at www.cor.net.

RICHLAND PARK/OAKS HOMEOWNERS ASSOCIATION ANNUAL MEMBERSHIP MEETING [11/8/2012]

Rank	Ref#	Description	Est. Cost
2	1	Lighting at Entrances: Install flood lights on a dusk to dawn power plan at each of the neighborhood entrances. We would do a couple of entrances a year over the next several years, starting with the two Walnut entrances.	\$3,000 per entrance install, and approx \$30 per month per entrance electric bill.
4	2	Boulders or Metal Posts at Entrances: Prevents autos from damaging decorative walls and entrance markers, something that has happened several times this year.	Unknown
1	3	Lighting Throughout Neighborhood: Neighbors have reported that lighting is poor with just two street lights per block. The height of current poles causes blocking of some lights by surrounding trees. COR & Oncor say responsibility is with homeowner to trim around those blocked street lights. Lower lights and more of them is one solution we are looking into. Changing city code enforcement to make the city responsible for tree trimming around lights is another option.	Unknown
6	4	Boulevard Lighting On Richland Park Drive: On the corners of Richland Park Drive North & South through our neighborhood, add gas light style lighting that gives a distinguished "boulevard" look. Consider other intersecting streets that are entrance / exit streets.	Unknown
3	5	Neighborhood Security Improvements: Some neighborhoods are gated communities; some have security systems on entrances and key intersections, & some residents have suggested making our alley ways "private drives" to limit traffic. We would research and make a proposal.	Unknown
8 50% for Do All	6	Curb Painting for Resident Addresses (Every 3 years): This past year we painted all the curbs in our neighborhood with white background & black lettering. This gave consistency to street appearance and aided emergency vehicles in identifying addresses. In addition to ranking this project, we want to know if you think in the future we should do "HOA Members Only" or the entire neighborhood. 7	7	Improvements for City Park Next to Elementary School: The COR is responsible for all improvements and maintenance, but we can recommend matching fund or COR projects, like the Volleyball court completed a few years back. One suggestion is lighting along walkways that would be lit from dusk until park closes. Another is enlarging the pavilion.	Unknown
10	8	Create Decorative Columns on Walls that Frame Neighborhood: Our current walls are stamped pebble rock / concrete mix to give a brick appearance that is very durable. COR has certain requirements that we may have to meet. These walls are not painted, so they can be pressure washed. This project would design an improvement to the columns – for example using sprayed limestone or a decorative brick shell that matches the brick used with the new entrances. Toppers could be added to the columns if desired to give a distinguished roof effect. (See example with walls in the newer development just north of us – Buckingham Villas).	Unknown
5	9	Repair Cracks and broken areas on Walls that Frame Neighborhood (Outside only): There are cracks in the walls, broken off sections mostly towards the bottom of the walls that need repair.	Unknown

One example is north side of 600 Sheffield with a wall facing Audelia that gathers leaves 3 feet deep each fall. This would involve contracting with a firm for cleanup once each year.	Unknown
11	11	Clean Inside of Walls framing the neighborhood – Outside walls were completed this year. This would involve pressure washing the inside of these walls.	Approx. \$3,000 for all walls.




