

# President's Public Service Announcement

#### Howdy Neighbor,

It has been a busy couple of months. The City Manager's office and Neighborhood Vitality Department made their formal recommendations to City Council for use of the bond money allocated to neighborhoods for architectural improvements and Richland Parks/Oaks has received a large portion of that money for entryway improvements at six locations. Curtis Dorian and his team have done a fantastic job and deserve many thanks! The fact is, many people on the board have been developing this for a couple of years (Ken Schuman, Susan Mather, and others) and all have had an impact...job well done!

In case you haven't heard, COR has been taken to court by Zone de Erotica, a Colorado-based business that has cleverly represented itself as NON "sexually oriented" and as such not subject to policies that our city has used in the past to discourage entry. It is a first amendment fight, not a statutory issue. The media has sensationalized the story, but certainly raised the issue into the limelight. If you have questions or want updates, I recommend the COR website (http://www.cor.net/). I think it is important that we understand the city DOES NOT want this kind of business operated here, and is being very proactive in defending its position.

I don't want to get too editorial on this subject but I do want to share with you some insight because many of you have expressed interest and concern regarding the city's actions on this matter. The city has extended a moratorium until May 13 (as long as courts would give, and this is a second extension) to pursue options, and as such they have been expediting processes and communications. I believe all COR parties involved have genuinely been interested in only serving the citizen's best interests, though given the emotional component of the issue they needed to communicate better. You should all have received a letter from the mayor and the website is updated daily with developments. As citizens, it is a time to rally together and support this good effort.

Get ready for the Easter Egg Hunt...details are in this edition so look for them. Also, put the bike rodeo on your calendars...that is coming up in May!

Finally, please plan to attend the **May 17 general membership** meeting! We have never (to my knowledge) done this before but felt like it was an important thing to do, given several things that are being discussed for our neighborhood. I was ecstatic to see that the push in membership in our crime watch last summer has made such a positive impact in our crime stats (being republished in this issue) and am really excited about the upcoming entryway improvements and beautification. The board would like your feedback so please plan on heading up to Richland Elementary May 17!

# Recalculated data indicates decrease in crime incidents

Further study of neighborhood crime stat comparisons from 2005 to 2006 has revealed a data error which caused a false report indicating a **17 percent** increase in crime from 2005 to 2006.

New figures indicate that there has, in fact, been a significant **decrease** (7.5%) in crime for 2006.

The cumulative total of incidents in 2005 was 93 rather than 66 that was reported in the February edition of the "Richland News."

Congratulations to our Crime Watch volunteers for the hours they donate to patrol the neighborhood.

Patrols are scheduled morning, afternoon, night and deep night with many slots still open—especially the early morning hours (deep night).

At the May General Homeowners meeting you will be provided with information about possible supplemental crime watch services and will have an opportunity to provide the Board with your ideas and concerns.

Several residents are having trouble keeping neighborhood cats out of their vegetable and flower gardens. Seems that the cats—all well groomed and with collars—enjoy using the gardens as litter boxes.

If you are a cat owner/lover please try to keep your cat at home.

Here's a tip for gardeners from another neighbor. If you have a Sweet Gum tree or know of one, collect the spiny seed pods (now all over the ground) and spread them heavily in flower and vegetable beds.

The spiny pods irritate cat paws causing them to avoid those areas.

#### Hello Neighbors,

I would like to take the time update you on the Neighborhood Vitality Program and the scope for Projects.

Let me start by explaining the difference between Architectural Funding and Beautification and Landscape Funding:

Architectural funding is created from Bond money awarded to the C.O.R. and then allocated for city projects and neighborhood improvements.

Beautification funding is created through a matching fund program awarded for the neighborhoods and funding from contributions of our HOA revenues for landscaping and maintenance.

A City Council Meeting was held on February 12<sup>th</sup> to discuss the next phase and proposed outcome of our request for improvements.

Although our original application with request for improvements covered a larger scope of projects and required an estimated cost of \$3,437,359.00, the city is recommending the following disbursement of \$240,120.00 for Richland Park/Oaks.

The main Project on the table is to enhance our Entries at 6 locations:

- 1. Park Bend @Abrams
- 2. Richland Oaks Drive @Walnut
- 3. Richland Park @Walnut
- 4. Wentworth @Walnut
- 5. Stillmeadow @Walnut
- 6. Tiffany Trail @Walnut

The estimated cost of this project is approx. \$237,000.00.

The city is amenable to using matching funds for additional projects and improvements within our community, such as:

1. Adding additional landscaping along the screening walls at the locations men-

tioned above.



### Description of "Original" Proposed Projects

This proposal is inclusive for both the Richland Park and Richland Oaks Community.

Closure of entrances into Richland Park and Richland Oaks:

- Closure of entrances on Audelia and Lois Lane at Walnut.
- Closure of entrances on Abrams leaving Park Bend open, providing access for the Elementary School and the Park.
  - Closure of entrance on Tall Oaks from Abrams, leading into Richland Oaks.

Thus leaving a total of 3 entrances open into Richland Park and 1 into Richland Oaks.

Entry Designs and Screening wall designs:

- Provide Main Entrance Designs including water features, landscaping, sprinkler modification and lighting.
  - Provide Extended Sprinkler System along Screening wall and additional landscaping.
  - Provide or Modify/Re-Design existing Screening walls at Abrams, Walnut and Audelia.






